MANAGER'S REPORT

- MSW is steady. We are working in a very compact area as the cell was designed with no access road, as a result it is making it very difficult to fill the cells normally. We are still seeing very good results from the packer on compaction. We are also seeing better results from narrowing the cells to combat the lose of paper and plastic.
- The Industrial cell just started its 1st big job of the year; the estimated contaminated soil will be around 5600Tonnes.
- The new industrial cell is formed in now and the composite liner has been installed. The Clay will now be hauled and packed over the composite liner leachate pipes, and gravel can be installed and then the cell is open for business, roughly about 3 weeks.
- I am looking at an alternative product to replace the drain rock used for final fill. This product is recycled tires and there is a provincial grant out right now which makes this a possible alternative.
- We had a visit from Alberta Recycling, I gave them a tour and showed them the changed we have made. He was very impressed with everything and wants to use us as an example for other Landfills.
- Recycling is staying very busy, the recycle attendants are handling it well.

- Met with the M.D. on the 24th to go over a few issues with the eco center.
- Recycling in the CNP has not changed, we continue to find garbage and mattresses, all which is not recycling.
- A long time employee of 8 years Lou Delauw retired and requested a donation to CNP Food Bank be made in exchange for a retirement party, so we sent a cheque along with a letter to the food bank.
- The New Mechanic continues to strive, he has become a real asset, he continues to want to take on more responsibility which in turn is freeing up some time for myself and the lead hands.
- The Entire crew has stepped it up this year as we have been suffering from lack of manpower since May due to surgery's, Sick leave, and Holidays.
- I have hired 2 people to help with the manpower, 1 has already started at the Eco Center and the other will be filling a new role at the Landfill.
- The new D-8 finally arrived and is pushing way more soil in less time. This is being done with 1 dozer instead of 2.
