# **COMPLAINT**

The MD of Pincher Creek has received a complaint of plastics and paper blowing over the hill to the east. Emile Saindon explained that with winds at 70-90+ km/hr., the fences do not catch all the blowing paper. Landfill staff are picking regularly to keep debris at a minimum.

It was noted that future complaints should be addressed to the Landfill Manager, rather than to the MD of Pincher Creek.

# REGIONAL WASTE AND RECYCLING PROGRAM UPDATE

Emile presented cost comparisons and startup costs for the proposed regional waste program. He stated that he has met with public works personnel from each community to determine the number of residents and hours needed to provide waste pick up services. He stated that it will take a minimum of 120 days to order, receive and ID the curb side bins. Emile suggested that if the program is to move forward, each Council should proceed with open house sessions for public information and education by April 2015.

It was the general consensus that the proposal should be presented at a Regional meeting, for further discussions. Professional services should be obtained, and a Memorandum of Understanding between all communities be established.

## SCHOLARSHIP APPLICATION

Board members considered 3 applications for the Landfill Environmental Science and Technology Scholarship. It was determined that 2 of the applicants were ineligible.
