#### **MANAGER'S REPORT**

- 1. MSW volumes are steady.
- 2. Ind. cell volumes have picked up in Aug and target is approx. 5000 tonnes for the month.
- 3. Construction on new MSW cell is 80 % completed liner install just beginning.
- 4. Engineered drawings for recycle center have not arrived yet.
- 5. D6 dozer has returned and repairs completed under warranty.
- 6. Shell Canada will be doing a site audit on Aug 15 as part of their program for suppliers. All material is ready for tomorrow's meeting
- 7. Waiting news on RDEK contract still nothing to report
- 8. Working on new contracts with Tervita for ind. cell materials.
- 9. Will be away on holidays from Aug 16 to Aug 26<sup>th</sup>.
- 10. Tervita is working on materials from the High River flood. Currently BFI in south Calgary are accepting the wastes, but some may come to the Cowley landfill when remediation begins.

#### LANDFILL BILLING STRUCTURE POLICY

Board Members reported discussing the recommended billing structure proposal at their Councils. The Town of Pincher Creek and the Village of Cowley are in agreement; the Municipal District of Pincher Creek has not had a meeting as yet; and the Municipality of Crowsnest Pass has referred the matter to their Policy Committee. The matter will be discussed at the next Board meeting.

### **COMMUNITY VENTURE**

Emile Saindon made a formal presentation in support of the Landfill obtaining a self-contained concession trailer for use by non-profit organizations within our communities. Volunteers are finding it difficult to meet restrictions imposed on food services by Alberta Health Services, and a fully equipped concession trailer would eliminate the majority of issues encountered in operating a temporary food vending amenity. The cost of a trailer would range from \$30,000 to \$100,000, depending on whether it was new or used, and depending on the size and range of equipment. Emile presented pictures of possible trailer set ups that were in the \$25,000 to \$30,000 range. Further investigation will be needed to determine final pricing.

#### Brian Gallant

Moved that a budget of \$35,000 be set for the potential purchase of a concession trailer. More details will be presented to the Board before proceeding with the purchase.
